Newsletters & Social Media

We send a quarterly newsletter to all our members, which shares recently published FCR research, as well as opportunities to engage in FCR research and educations. IPOS advertises these opportunities to the wider IPOS community via the IPOS newsletter. Several FORWARDS members also actively promote FCR research on Twitter; the committee members alone having 5560+ followers.

Collaborations

A Delphi-study led by dr. Custers (Radboudumc, the Netherlands) on features of fear of progression in advanced cancer patients receiving systemic treatment was conducted from December 2022 – January 2023. Six members of the SIG are in the steering committee of the project and 22 SIG members participated in the Delphi rounds.

Forwards members Tania Estape and Christine Maheu published a scoping review: Maheu, C., Singh, M., Tock, W. L., Eyrenci, A., Galica, J., Hébert, M., ... & Estapé, T. (2021). Fear of cancer recurrence, health anxiety, worry, and uncertainty: A scoping review about their conceptualization and measurement within breast cancer survivorship research. *Frontiers in psychology*, *12*, 644932.

The Individual Patient Data Meta-analysis on the Fear of Cancer Recurrence Inventory is being conducted by Yvonne Luigjes and led by FORWARDS members was published in Psycho-Oncology

Several other FCR-related reviews by teams made up largely of FORWARDS members were published: on FCR costs (team Ben Allen Smith); FCR in cancer caregivers, (team Sophie Lebel) FCR in Indigenous and minority populations (team Ben Allen Smith).

3) To continue to promote activities of FORWARDS and engage the membership, also for early career members. Results: see above

3. Description of issues/challenges experienced in 2022

We have talked to a very good patient representative but are a bit unsure about how to proceed: how can we involve her in FORWARDS activities. Our Early Career member had to stop due to personal circumstances, which made the workload for the other members more intensive.

The webinars were restricted to English-speaking people, closed captions in English is available, but unfortunately, we did not succeed in finding funding for using a live-translation tool to translate in Spanish or other languages.

4. Goals for the next 12 months: 2023

We aim to facilitate collaboration on research projects in the priority areas identified in the two Delphi studies that were conducted by our members:

- Intervention research to facilitate greater access to FCR treatment, specifically for LMIC and indigenous communities
- Evaluation of the effectiveness of FCR interventions in real world settings
- Defining the mechanisms of action and active components across FCR/P interventions

Furthermore, we aim to continue with quarterly webinars on FCR available to FORWARDS members and the IPOS community and to continue to promote activities of FORWARDS like activities for early career researchers.

5. Any special requests/needs for the next 12 months

In order to make our research results available for a diverse group of IPOS members it would be really helpful if IPOS help to provide translation of the webinars that are on the IPOS website, so that people can look back. For example in Spanish, but also in other languages.
